ANNEXURE-I

TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLES AGAINST TENDER ENQUIRY NO.19-1/2009-ADMN.IIA DATED 23.06.2009.

Interested Parties may submit their highest prices for each vehicle individually in a sealed cover latest by 3.00PM on or before 10.07.2009. The inner cover containing quotations and other relevant documents alongwith DD/Pay Order/Banker's Cheque towards EMD should be sealed properly. The cover should be put in another Outer Cover and may be dropped in the Tender Box of Admn.II(A) Section kept at the Reception of the Technology Bhavan, DST, New Delhi. Both the inner and the outer covers should be superscribed in Bold Capital letters "**QUOTATIONS FOR DISPOSAL OF VEHICLES**".

2. The disposal of vehicle shall be strictly on "**AS IS WHERE IS BASIS**" and no guarantee or certificate of its worthiness or quality will be given by this Department. The condition of the vehicles can be inspected physically between 11.30AM to 5.00PM on any working day between 6.07.2009 to 8.07.2009 at Technology Bhavan, by contacting Shri Biswanath Sahoo, Section Officer (Admn.II-A Section), DST, New Delhi (Tel:26590225, 26590575).

3. The quotation should be accompanied by earnest money for Rs.12,000/-. The earnest money can be deposited by Bank Draft in favour of DDO, Department of Science & Technology. The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest tenderer/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

4. EMD amount is payable by means of DD/Pay Order/Banker's Cheque in favour of DDO, Department of Science & Technology, New Delhi. (Payment by Cheque/Cash shall not be accepted). Offers received without EMD amount shall not be considered at all by this Department.

5. The successful bidder will be required to deposit the total bid amount by means of Demand Draft/Pay Order/Banker's Cheque in favour of DDO, DST, New Delhi within three working days of award of the contract.

6. EMD of the successful bidder(s) will be released only after realization of Sale proceed amount. Earnest money Deposit of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD amount will not be adjusted in the Sale Amount accepted by DST. EMD of successful bidder(s) shall be released only after successful completion of the sale process.

7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters Identity Card in case of individual and Registration Certificate in case of firms etc.)

8. The sold vehicle will be removed by the successful bidder(s) within 48 hours of depositing the money at their own expenses. No assistance/transportation will be provided by

DST. Permission to take out the disposed vehicles from DST premises will not be allowed on holidays, Saturdays, Sundays etc.

9. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.

10. EMD of the firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of DST shall be final in this regard.

11. The Government (DST) reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.

12. EMD of unsuccessful tenderers shall be returned within three weeks of the award of contract to successful party.

13. The bidder is to required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.

14. Disputes, if any, shall be subject to jurisdiction in the Court of Delhi only.

15. If the highest quoting firm fails to honour the bid; the contract will be cancelled & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party. In case of any dispute, decision of DST shall be final.

16. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.

17. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.

19. This being a Limited Tender Inquiry, only the listed firms are required to submit their quotation. Tenders received from only firm other than the listed firms will be treated as unsolicited and therefore be rejected.
