2. Interested parties are requested to submit their application in the prescribed format (Form A, B, E etc., whichever is applicable) appended to this Notice duly filled in complete with all annexure and supported with documents called therein.

3. Companies/firms/concerns holding a valid Registration Certificate or Rate Contract or having successfully executed supply order of these/similar items recently of a reckonable magnitude from DGS&D/NSIC shall be eligible for grant of automatic Registration without any verification.

4. Application received shall be scrutinized thoroughly for establishing technical competence, financial soundness and decent marketing behaviour of the applicant firm. The verification process may include visit and inspection of the firm premises, Offices, Godowns and factory.

5. Vendors satisfying the qualification criteria shall be put on the Registration list of this Ministry for supply/maintaining of the concerned stores for a period of three years from the date of issuance of registration certificate subject to their satisfactory compliance of conditions prescribed by DST. In case they fail to abide by the conditions laid by this Department and are found violating any statutory provisions their registration may be terminated at any point of time with a due notice of two months. This Department reserves the rights to grant registration to one or more vendors for the same item.

6. Registration granted by this Department shall not be deemed to be on par with the Registration granted by Government of India, DGS&D, NSIC or State Governments. Mere Registration with this Department will not *ipso facto* entitle a firm to award of any contract/supply order.
7. The registered vendors will be invited for quoting their best prices against limited/advertised tenders floated for the subject stores by this Department. The Department, however, reserves the right to continue source development/tap additional sources of supply and invite additionally known parties to participate in the limited tender enquiries of this Department.
8. Firms already registered with this Department need to apply afresh and need to apply after expiry of valid registration certificate.
9. Applicants are advised in their own interest to visit the Technology Bhavan and acquaint themselves with the existing infrastructure to have a better idea of the likely acquirements of the stores by this Department. No commitment can be made or minimum quantity guaranteed at the time of registration.
10. There is no processing fee or application fee for Registration with DST. Applications submitted in the relevant Proforma appended herewith will only be considered or processed. Application complete in all respects may be submitted to the undersigned immediately. Registration process remains open throughout the year. However, Limited Tender floated for the item by DST will be issued to only those firms who have already secured registration on the date of issue of Limited Tender. Only those vendors will be allowed to compete/ quote tender, who have been granted Registration on or before the Tender opening date. Request for postponement in Tender opening date due to delay in securing registration shall not be entertained.
