Applications are invited for filling up of two posts of Hardware Engineer and two posts of System Analyst on deputation basis in National Spatial Data Infrastructure (NSDI), Department of Science and Technology as per details given below:-

1. **NAME OF THE POST:** Hardware Engineer (two posts)
2. **SCALE OF PAY :** Rs 37,400-67,400 (PB-4)(Grade Pay Rs. 8,700)
3. **MODE OF RECRUITMENT:** Deputation
4. **PERIOD OF DEPUTATION :** Initially for a year but likely to continue for 5 years.
5. **QUALIFICATIONS AND EXPERIENCE :**

Officers of the Central Government:

- (a) (i) holding analogous posts on regular basis in the parent cadre or department; or
(ii) with five years' service in the Grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 15,600-39,100 (Grade Pay Rs. 7,600) or equivalent in the parent cadre or department; and
- (b) (i) possessing the following Educational Qualifications and Experience:

Essential :

- (A) (i) Master's degree in Engineering or Technology with computer specialization in Spatial Data – base, and
(ii) ten years on the job experience in the field of 'Spatial Data';

- (B) (i) Master's degree in Science or Mathematics or Economics or Statistics or Operational Research or Management ;
(ii) twelve years' on the job experience in the field of 'Spatial Data' ; and

(ii) with three years' service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 6,500 - 10500 (Pre - revised) or equivalent in the parent cadre or department; or
(iii) with seven years service in the grade rendered after appointment thereto on a regular basis in the scale of pay Rs. 5500 – 9000 (Pre - revised) or equivalent in the parent cadre or department; and
- (b) (i) Possessing the following educational qualifications and experience:
 - (A) (i) Master's Degree in Computer Application or Computer Science or Master's Degree in Technology (with specialization in computer application) or Bachelor in Engineering or Bachelor in Technology in Computer Engineering or Computer Science or Computer Technology from recognized university or equivalent; and

 - (D) (i) 'A' level Diploma under Department of Electronic and Accreditation of Computer Courses Programme or Post Graduate Diploma in Computer Application offered under university programme or Post Polytechnic Diploma in Computer Application awarded by the State Council of Technical Education or equivalent; and
(ii) Six years experience in Electronic Data Processing out of which at least three years experience should be in actual programming.

GENERAL

1. Out station candidates called for interview for the post of Hardware Engineer and System Analyst will be paid to and fro 1st Class / III tire AC and Second Class railway fare respectively by shortest route, on production of proof of journey such as railway ticket(s) / number(s) etc.
2. The selected candidates are liable to be posted anywhere in India and outside.
3. The terms and conditions of appointment will be in accordance with the Department of Personnel & Training's O.M. No. 2/29/91-Estt.(Pay.II) dated 5th January, 1994, as amended from time to time.
4. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization / Department of the Central Govt. shall ordinarily not exceed five years for the post of Hardware Engineer and three years for the post of System Analyst.
5. The Maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.
6. The Curriculum Vitae duly supported by documents will be assessed by the Selection Committee while selecting candidates for appointment on deputation.
7. The candidates who apply for the posts will not be allowed to withdraw their candidature subsequently.
