Applications are invited from Indian citizens for filling up of one post of Scientist 'D' by direct recruitment on contract and co-terminus basis (till March 31, 2012) in the Innovative Cluster Scheme in National Science and Technology Entrepreneurship Board (NSTEB), Department of Science & Technology as per details given below :-

SCALE OF PAY : Rs. 15600-39100 (Grade Pay- Rs. 7600/-)

NO. OF VACANCIES: ONE

(a) ESSENTIAL EDUCATIONAL QUALIFICATION :

Master's Degree in Natural /Agricultural Science or Bachelor's degree in Engineering / Technology / Medicine from a recognized University or equivalent.

(b) DESIRABLE QUALIFICATION :

Doctorate Degree in areas related to cognitive neuroscience / computational neuroscience etc.

(c) EXPERIENCE :

Experience of eight years in Research and Development in Industrial and Academic Institution and / or Science and Technology Organizations, out of which four years should be in Science and Technology programme, planning, development and coordination.

AGE: Not exceeding 40 years for the post of Scientist 'D' as on the last date for receipt of applications. Provided that the upper age limit is relaxable for the Scheduled Castes, the Scheduled Tribes, the Ex-service men, Other Backward Classes, Physically Handicapped and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard the controlling authority may relax the upper age limit in case of highly experienced candidates in specialized scientific areas.

GENERAL

1. The number of posts to be filled may vary. The Department reserves the right to cancel the recruitment without assigning any reason.
2. The prescribed essential qualifications are minimum and the mere possession of the same does not entitle candidates to be called for interview.
3. The appointments against all the posts shall be on contract basis and co-terminus with the duration of the Scheme which is upto 31.03.2012.
4. Outstation candidates called for interview will be paid to and fro second class rail fare by the shortest route.
5. The selected candidates are liable to serve anywhere in India and outside.
6. Experience will be counted after completion of essential academic qualifications. While completed degree of M.Tech will be counted as two years or the actual duration of the course, whichever is less, completed Doctorate degree will be counted as three years or the actual duration of the course, whichever is less, towards experience. In case, a candidate has obtained the above degree(s) while in service, only his service period will be counted towards experience and he will not get any additional weightage in experience for acquiring M.Tech. / Doctorate towards total period of experience.
7. **CANVASSING IN ANY FORM WILL RESULT IN DISQUALIFICATION OF CANDIDATURE.**
8. **HOW TO APPLY :** Applications should be neatly typed on thick plain paper (A-4 size 210 x 297 mm) in the prescribed format given below:-
 - (a) A self-addressed post-card with requisite stamp should be sent along with the completed application. Candidates should indicate in this card the Advertisement number and name of the post applied for. The applications will be acknowledged by the Department by returning this card to the candidates after indicating the Registration number allotted to them. Candidates may note that no separate acknowledgement other than this card will be sent to them.
 - (b) Candidates working in Government Departments / Public Sector Undertakings / Autonomous organisations **should apply through proper channel.** Their applications must be accompanied with photocopies of upto date ACRs for the last five years (duly attested on each page by an officer not below the rank of Under Secretary or equivalent) and vigilance clearance.

- (c) Copies of certificates in support of educational qualifications, date of birth, Physically Handicapped, Community (in case of SC/ST/OBC candidates only) and experience should be attached with the application. Candidates will have to produce the original certificates as and when required.
- (d) **Applications received after the closing date or received incomplete in any respect are liable to be summarily rejected. No representation against such rejection will be entertained.**
